The Board discussed issues regarding temporary employees' right to distributions from their retirement accounts. Outside legal counsel is recommended. Innovest has recommendations for attorneys who have dealt with this. The Board will pay for expert assistance and will continue the conversation following legal review.

The Board discussed having representation of retirees as part of meetings. More research of state statutes and board by-laws is required to determine ability to bring on a retiree as a voting Board member. Retirees can be invited for public comment. The 401(a) participant count at the end of the fourth quarter was 2,457 total with 1,970 active.

Motion by John Feyen to use Innovest to advise the Board through the RFP process. Seconded and passed without dissent. Bruce Peters will notify Purchasing that the Board will use Innovest for the RFP process and determine what level of communication is required with Purchasing.

Motion by Nancy Baker for Bruce Peters to continue as Chair. Seconded and passed without dissent. Motion by Nancy Baker for John Feyen to serve as Vice Chair. Seconded and passed without dissent.

TIAA presented a brief summary for fourth quarter.

Bruce Peters is currently the only member attending the TIAA conference held April 23-25 in Scottsdale, Arizona. Funds to send any Board members to this conference are covered through the Retirement Board budget. Bruce Peters will provide Board member emails to Paul Krajcir so that individual invite can be sent.
