# LARIMER COUNTY INTERAGENCY OVERSIGHT GROUP MEETING MINUTES

- I. Call to Order: Thad Paul at 11:35 AM
- II. Welcome and Introductions
  - Introductions were made around the table.
- III. Review and Approval of Minutes from April 11, 2019
  - Motion for approval was made, second motion made Minutes approved for April 11, 2019.
- IV. Provider/Community Presentation Stephen Thompson, UC Health Care Coordinator
  - Oversees three community-based programs that focus on children and adolescent welfare, keeping kids safe in the community and prevent out of home placement
  - How programs grew & resources for this group:
    - i. 2011 Initiative: Accountable Care Collaborative (ACC) in Colorado
    - ii. July 2018: ACC Phase 2.0 began Behavioral health management now also falls under the Regional Accountable Entities (RAE's) purview
    - iii. 2018 present: Every fully benefitted Medicaid patient is now mandatorily enrolled in the ACC
    - iv. RAE #1: Rocky Mountain Health Plans (RMHP) Long standing 40 plus years in Colorado. Organization based out of Grand Junction, provides health care coverage to nearly 220,000 enrollees statewide
    - v. Medicaid Accountable Care Collaborative (MACC) program provides intensive, community-based care coordination and services and support to fully benefitted Medicaid patients who have extensive and complex medical, behavioral health and community resource needs.
    - vi. Healthy Harbors Program provides intensive community-based care coordination services to at risk children and families who are impacted by child welfare concerns.
    - vii. Larimer County Department of Human Services (LCDHS) is a collaborative partner with Healthy Harbors who can be a liaison with families working with LCDHS.
    - viii. Nurse Home Visit Program post partum home visits to Medicaid infants and families, program does nursing assessments of the newborn, lactation support, communication and more.
  - Organizational Structure: overview
    - i. MACC, Healthy Harbors and Nurse Home Visit staffing: Total FTE, Colorado Health Initiative (CHI) Care Coordination Team: 17.7

- ii. MACC Team Staffing and historical growth: 3.8 FTE in 2011 and 11.8 FTE in 2018
- iii. Total county wide care management resources now 50.7 FTE
- Take Home Points: Where a Medicaid patient goes for primary care is the main triage point to determine which team picks up a given referral
- Program Volume:
  - i. Current number of open clients, MACC and Healthy Harbors: 540+ open cases as of May 2019
  - ii. Current number of pending referrals 92 pending referrals coming from all over the community
- Connection with primary care, what are the gaps? Common interventions, outreach, intake assessment, medication support, connection services
- Well-child compliance rate for current Healthy Harbor clients: State-wide compliance rates for children on Medicaid all ages 30%
- Questions:
  - *i.* How long are you involved with the family? *Varies quite a bit. Average length is 9-12 months, sometimes have 4-5 years.*
  - *ii.* What has helped clients to know the system? *Relationships and the networks we have and knowing the point person is critical to provide wrap around services.*
  - iii. What would be helpful? So many resources, invite and have them educate us on services, and resources. Trying to stay current with all that is out there.iv. Is Hospico involved? Yes
  - iv. Is Hospice involved? Yes.
- V. Review and Discussion of Placement Data (attached) Thad Paul
  - ADP by placement Type: Numbers are consistent. Volume of increase of Average Daily Placement (ADP) within the family setting stands out
  - Slow rise month over month? Had some difficult cases, kids getting hurt, opioid use, lost some programming. No one clear cause for our numbers going up.
  - Thad Paul met with Cyndi Dodds from SummitStone Health Partners and they are working on capturing the Medicaid data/piece.
- VI. Budget Review (attached) Thad Paul
  - Our fiscal year runs from July 1 June 30: We've started payback to this group part of why number looks lower, didn't put this payback data in yet.
  - LCDHS made a commitment to this group 10 years ago to support each other keeping kids out of congregate care.
- VII. Community Collaboration to Strengthen and Preserve Families Thad Paul and Judy Rodriguez
  - In the process of applying for the Grant: Community Collaboration to Strengthen and Preserve Families
    - i. Due date is June  $11^{th}$
    - ii. Five-year grant: one-year focus developing a stronger collaboration across the community and identify site locations/agencies we can refer families
    - iii. Needing to have one-point person in an agency to get needs met
    - iv. Will have navigator positions. Work with Anthony Silverman and Colorado State University to do a needs assessment (service array), do a world café: bring communities together to identify services available, better collaboration to get families to the right place at the right time.
    - v. To avoid child maltreatment, we need to break generational cycle

- vi. Asks: Letters of support. One from this Board that would be signed by cochairs (Michelle Brinegar and Averil Strand) and list agencies on the bottom of the letter.
- vii. Add Michele Christensen's name to the letter as a LCIOG member
- viii. Add trauma information to the grant as we serve these families.
- *ix.* Motion made to move this letter for approval with some mild modification. Motion passed.
- x. There will be a separate letter for integral partners who would be more active, i.e., school districts and SummitStone Health Partners.

### VIII. Old business:

- Memorandum of Understanding (MOU). Contact Deb Bowen, Ali Wright or Judy Rodriguez. The State requires submission very soon. The actual content has been submitted. The final document with all signatures and approval by the Board of County Commissioners is due July 1. Be prepared to share next time with any feedback.
- IX. New Business:
  - House Bill: Juvenile Justice Reform Bill passed. It redefines kids that can or cannot be contained.
  - Bill 210 also passed. It reduced the detention cap from 21 to 14 locally and 378 322 statewide. Danger to self is no longer enough to detain and children cannot be detained specifically due to lack of placement.
  - A mobile Medication-Assisted Treatment (MAT) van will be coming to provide MAT services in our community and will be releasing a Request for Proposal (RFP). Looking for providers to do recovery support services. Information will be shared with Thad Paul and Deb Bowen so information can be shared with this group.
  - 8<sup>th</sup> Judicial District (Larimer and Jackson Counties): A liaison for adults and juveniles will be available to make sure information is being passed along to them.
  - The first act of the Family First Preservation Services Act has passed.
- X. Review Applications for New Board Members
  - Michele Christensen, Director of Program Development at Housing Catalyst, may be appointed by the Board of County Commissioners as a Community Member at Large to the LCIOG board. Housing Catalyst is the public housing agency in Fort Collins.
  - Recommendations for board members are welcomed and applicants are invited to apply to the LCIOG Board.
  - Review terms of existing Board Members at next meeting.
