Call to Order - Jennifer Lee, board president, called the meeting to order at 5:01 p.m.

Public Comment - There was no public comment.

UPDATES

Financial Report – John Voss, Accounting Manager for Larimer County Department of Health and Environment, provided the financial report.

Directors Update - Tom Gonzales, Public Health Director, provided an update on COVID-19. Tom invited several experts from the COVID-19 suppression response to provide updates. Resolution on COVID-19 Priorities - Jennifer Lee, Board President, introduced a Resolution on COVID-19 Priorities. The resolution outlined the guidance going forward for the Department of Health and Environment's response to the COVID-19 pandemic.

ACTION: Dr. Bernard Birnbaum made a motion to pass the resolution. Brian DelGrosso seconded the motion.

It was seconded by Janna West-Kowalski. Dr. Birnbaum clarified that Tom should focus on the Suppression Plan before moving forward with submitting an application for a variance.
